P.O.*, a corporation hereinafter called Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Twenty-Five Thousand Five Hundred and No/100 Dollars (\$ 25,500.00), with interest from date at the rate of ten-per centum (10 %) per annum until paid, said principal and interest being payable at the office of Engle Mortgage Company, Inc., P. O.
