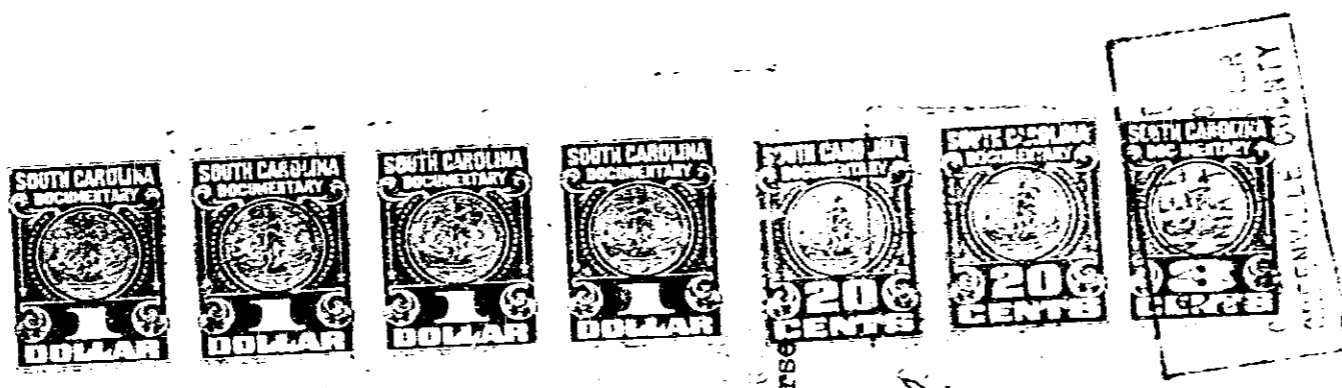
with interest thereon from December 27, 1974 the rate of 9% per centum per annum, to be paid:
