Being the same property conveyed to the Mortgagor herein by deed of M. L. Lanford, Jr., recorded in Deed Volume 1034 at page 808 This mortgage is second and junior in lien to that mortgage in favor of Fidelity Federal Savings & Loan recorded in Mortgage Book 1365, Page 11.

Together with all and singular the rights, members, hereditaments and appurtenances to said premises belonging or in anywise incident or appertaining. - 2. TAXES. Mortgagor shall pay all taxes, charges and assessments which may become a lien upon the premises hereby conveyed before any penalty or interest accrues thereon and shall promptly deliver to Mortgagee (at its request) official receipts evidencing payment thereof. In the event of the passage after the date of this Mortgage of any law imposing a federal, state or local tax upon Mortgage or debts secured thereby, the whole principal sum (together with interest) secured by this Mortgage shall, at the option of Mortgagee, its successors and assigns, without notice become immediately due and payable.
