"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, within the corporate limits of the City of Greenville, and being known and designated as Lot No. 22 of a subdivision known as Essex Court, a plat of which is recorded in the RMC Office for Greenville County in Plat Book W at page 31, and having the following metes and bounds, to-wit:
