MORTGAGE OF REAL ESTATE

TO ALL WHOM THESE PRESENTS MAY CONCERN.

WHEREAS, I, James G. Putnam

(hereinafter referred to as Mortgagor) is well and truly indebted unto **Rayford Thompson**

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

Dollars each commencing on the 1st day of December, 1979, with a like sum
being due and payable on the first day of each successive month thereafter
until the entire amount has been paid in full.

with interest thereon from date at the rate of **Ten** per centum per annum, to be paid: **monthly**

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of

Greenville, as follows, to-wit:

ALL that certain piece, parcel or lot of land, situate, lying and being on the southerly side of Scuffletown Road, Bulter Township, Greenville County, State of South Carolina, being shown as the northern portion of the property of Cora Durham as shown as a plat thereof made by C. O. Riddle, Engineer, dated September 12, 1968, and being described as follows:
