NOW, THEREFORE, in consideration of the aforesaid loan and the sum of Three Dollars (\$3.00) cash in hand paid to Mortgagor, the receipt of which is hereby acknowledged, Mortgagor hereby grants, sells, conveys, assigns and releases to Mortgagee, its successors and assigns, the following described premises located in _______ County, South Carolina:

All that certain piece, parcel, or lot of land, situate, lying and being on the southeastern side of New Haven Drive, Greenville County, South Carolina, being shown and designated as Lot 87 on a Plat of MERRIFIELD PARK, Section II, and recorded in the RMC Office for Greenville County in Plat Book WWW, at Page 51, and having, according to said Plat, the following metes and bounds:

Beginning at an iron pin on the southeastern side of New Haven Drive, joint front corner of Lots 87 and 88, and running thence with the common line of said Lots, S.53-94 E., 158.8 feet to an iron pin; thence S. 45-38 W, along the common line of said Lots, N. 50-33 W. 168.15 feet to an iron pin on the southeastern side of New Haven Drive; thence with said Drive, N. 49-35 E. 115 feet to an iron pin, the point of beginning.

- 2. TAXES. Mortgagor shall pay all taxes, charges and assessments which may become a lien upon the premises hereby conveyed before any penalty or interest accrues thereon and shall promptly deliver to Mortgagee (at its request) official receipts evidencing payment thereof. In the event of the passage after the date of this Mortgage of any law imposing a federal, state or local tax upon Mortgage or debts secured thereby, the whole principal sum (together with interest) secured by this Mortgage shall, at the option of Mortgagee, its successors and assigns, without notice become immediately due and payable.
