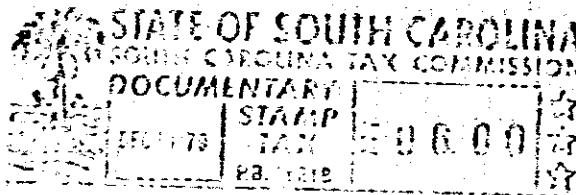

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, located within the limits of the City of Greer, being shown on a plat prepared by Wolfe & Huskey dated April 21, 1977 and being more particularly described as follows:

BEGINNING at an iron pin on Campbell Avenue and running thence, S. 89-00 W. 84.4 feet to an iron pin on the line of the Ruby Taylor property; thence, along that line N. 06-23 W. 189.1 feet to an iron pin on the line of Campbell; thence, S. 70-52 E. 42.8 feet to an iron pin; thence, S. 20-17 E. 187 feet to the beginning corner and according to said plat containing 0.25 acres more or less.

The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
