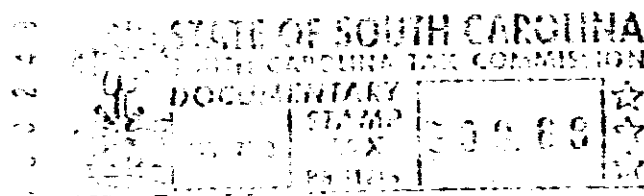
with interest thereon from date at the rate of ten (10) per centum per annum, to be paid as stated in said promissory note.

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Glassy Mountain Township, known as Lots Nos. 259 and 260 on plat of property of Lake Lanier Subdivision, reference to which may be had for a more particular description. Said plat is duly recorded in the Office for R.M.C. for Greenville County.

This being the same property conveyed to Mortgagor by DeViolet Bernhardt by deed dated January 3, 1980, to be recorded herewith.
