To secure payment of a note which I signed today promising to pay you the above Total of Payments and to secure all my other and future obligations to you, the Maximum Outstanding at any given time not to exceed the amount stated above, each of the undersigned grants, bargains, sells and releases to you the real estate described below and all present and future improvements on the real estate, which is located in South Carolina, County of Greenville

All that certain piece, parcel or lot of land, situate, lying and being in the County of Greenville, State of South Carolina, being known and designated as Lot No. 20 on a plat of Sheffield Forest, recorded in the R.M.C. Office for Greenville County in Plat Book "AAA" at page 47, and having according to said plat such metes and bounds as shown thereon. Said lot is 100' X 150'.

If I pay the note secured by this mortgage according to its terms this mortgage will become null and void.

Each of the undersigned waives marital rights, homestead exemption and all other exemptions under South Carolina law.

This mortgage will extend, consolidate and renew any existing mortgage you hold against me on the real estate described above.
