WHEREAS, Doug Vaughan and Ginger F. Vaughan,

S.C.S/A J. Douglas Vaughn  
of Greenville, County of Greenville State of South Carolina  
(Herein called Debtors), have applied to the Commodity Credit  
Corporation (herein called the Secured Party), for a loan and  
have agreed to give the Secured Party a security interest in

real estate to such security interest in said fixtures, and (3)  
agree that upon default of Debtors the Secured Party may (a)  
take possession of and remove said fixtures without notice to  
the undersigned parties and without liability to them for the  
cost of repair of any physical injury to or diminution of value  
of the real estate, and (b) enforce its security interest against  
said fixtures as personality.
