to Benchmark Properties, a Memorandum of which was recorded September 12, 1974 in Deed Book 1006, Page 595 in the RMC Office for Greenville County, South Carolina and reference to said Memorandum is hereby made for the purpose of excluding the property described therein from the property hereinabove described, AND LESS, ALSO, that certain piece, parcel or lot of land on the eastern side of Laurens Road adjacent on the south to that property leased to Benchmark Properties referred to above and being property now or formerly of Tobie Allen and leased to Exxon shown on the Greenville County Tax Maps as Sheet 273, Block 1, Lot 5.1, which property is excluded from the property hereinabove described.
