MORTGAGE

THIS MORTGAGE is made this 1st day of May 1980 between the Mortgagor, Amos L. Reade, Jr. and Eleanor I. Reade (herein "Borrower"), and the Mortgagee, FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, a corporation organized and existing under the laws of SOUTH CAROLINA, whose address is 101 EAST WASHINGTON STREET, GREENVILLE, SOUTH CAROLINA (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Twenty-eight thousand six hundred twenty-eight and 98/100 Dollars, which indebtedness is evidenced by Borrower's note dated May 1, 1980 (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on April 1, 2002;

To SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville, State of South Carolina:

ALL that certain piece, parcel, or lot of land, situate, lying and being in Greenville County, South Carolina, being shown and designated as Lot 21 on a Plat of FONTANA FOREST, recorded in the RMC Office for Greenville County in Plat Book YY, at Page 171, and having, according to a more recent survey by Freeland & Associates, dated April 24, 1980, the following metes and bounds:

BEGINNING at an iron pin on the northern side of Tamarack Trail, joint front corner of Lots 20 and 21, and running thence with the common line of said Lots, N 17-37 W, 17 50 feet to an iron pin; thence with the rear line of Lot 21, N 72-23 E, 100.0 feet to an iron pin on the western side of Pennwood Lane; thence with Pennwood Lane, S 17-47 E, 150.0 feet to an iron pin; thence with the curve at the intersection of Pennwood Lane and Tamarack Trail, S 27-18 W, 35.2 feet to an iron pin on the northern side of Tamarack Trail; thence with said Trail, S 72-23 W, 75.5 feet to an iron pin, the point of beginning.

This is the same property conveyed to the Mortgagors herein by deed of Bobby G. Murray and Agilee M. Murray, dated May 1, 1980, to be recorded simultaneously herewith.
