All that piece, parcel or lot of land, with all improvements thereon or nerealter constructed thereon, situate lying and being in the State of South Carolina County of Greenville, in Bates Township at Marietta known as Lot No. 10 on Plat of Oakmonte Section No. 1, recorded in Platt Book "GGG" at Page 99 and naving according to said plat the following metes and bounds to-vit.
