# MORTGAGE

THIS MORTGAGE is made this 1st day of August, 1980, between the Mortgagor, Janice L. Scheaffer, (herein "Borrower"), and the Mortgagee, First Federal Savings and Loan Association, a corporation organized and existing under the laws of the United States of America, whose address is 301 College Street, Greenville, South Carolina (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Thirty Thousand Four Hundred and No/100 Dollars, which indebtedness is evidenced by Borrower's note dated August 1, 1980, (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on August 1, 2005.....;

TO SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville, State of South Carolina:

ALL that certain piece, parcel or unit, situate, lying and being in the County of Greenville, State of South Carolina, being shown and designated as Unit No. 5-M of TOWN PARK of Greenville, S. C., Horizontal Property Regime, as is more fully described in Master Deed, dated June 5, 1970, and recorded in the RMC Office for Greenville County in Deed Book 981 at Page 243, as amended by Amendment to Master Deed recorded on July 15, 1971, in Deed Book 920 at Page 305, and survey and plot plans recorded in Plat Book 5-G at Pages 173, 175 and 177, as amended by Master Deed recorded in Deed Book 987 at Page 349.

THIS is the same property as that conveyed to the Mortgagor herein by deed from George W. Fischbach and Bonnie Fischbach recorded in the RMC Office for Greenville County of even date herewith.
