Page 133, said Lot having such metes and bounds as shown on said latter plat.

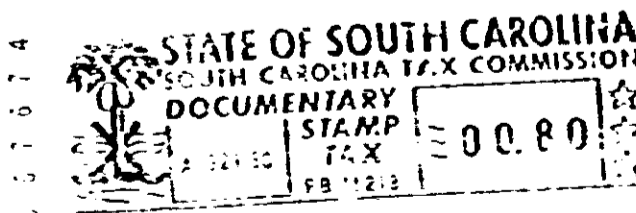
