MORTGAGE OF REAL ESTATE  
TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, We, Porter Garrett Styles and Cynthia A. Styles

with interest thereon from date at the rate of 12% per centum per annum, to be paid: Monthly

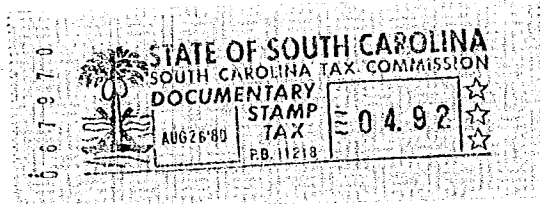

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of

Greenville, on the eastern side of Farmington Road, being shown and designated as Lot 31 on a Plat of CHESTNUT HILLS Subdivision, recorded in the RMC Office for Greenville County in Plat Book GG, at Page 35, and having such metes and bounds as shown thereon, reference to said plat being made for a more complete description.

This is the same property conveyed to the Mortgagors herein by deed of Jimmy E. Rodgers and Deborah Rodgers, dated August 26, 1980, to be recorded simultaneously herewith.
