beginning on May 1, 1980, in monthly payments of \$200.00, said payment including principal and interest, and payments due on the first day of each subsequent month,

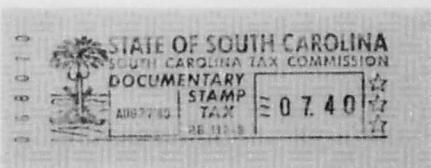
with interest thereon from _____ at the rate of **10.5%** per centum per annum, to be paid.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Monaghan Mills Village, and being more particularly described as Lot No. 93, Section 1, as shown on a plat entitled "Sub-Division for Victor-Monaghan Mills, Greenville, South Carolina" made by Pickell & Pickell, Engineers, Greenville, South Carolina on December 20, 1948, and recorded in the R. M. C. Office for Greenville County on plat book S, at Pages 179 - 181, inclusive. According to said plat the within described lot is also known as No. 3 Haynsworth Street (Avenue) and fronts thereon 65 feet.

The above described property is the same conveyed to me by Neoma A. Langley by deed dated AUGUST 25, 1980 and recorded in the R. M. C. Office for Greenville County in Deed Book 1132, at Page 48.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein.
