(\$239.64 ) Dollars each, the first instalment being due October 15 , 19 80, and the remaining instalments


are due on the 15th day of each month thereafter

ALL of that certain piece, parcel, or lot of land, situate, lying and being in the County of Greenville, State of South Carolina, and according to a plat prepared of said property by Carolina Surveying Co., December 10, 1973, and recorded in the RMC Office for Greenville County, South Carolina, in Plat Book 5B, at Page 52, and having the following courses and distances, to-wit:

BEGINNING at a point on the edge of Standing Springs Road, joint corner of said property and property now or formerly of Grover Riddle and Blythe Riddle and running thence, S. 34-45 W. 611.2 feet to an old iron pin; thence continuing with the joint lines of said property and property of Grover Riddle and Blythe Riddle, N. 50-30 W. 650 feet to an old iron pin; thence N. 69-50 E. 685.2 feet to an old iron pin; thence N. 74-21 E. 142.4 feet to a point on the edge of Standing Springs Road; thence running with said Road, S. 20-30 E. 198.5 feet, to the point of beginning.
