WHEREAS, the Mortgagor is well and truly indebted unto Associates Financial Services Co Inc

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

Nineteen Thousand Nine Hundred Twenty & no/100 DOLLARS (\$ 19,920.00).  
with interest thereon from date at the rate of 18 per centum per annum, said principal and interest to be repaid: in 60 equal monthly installments of \$332.00 each, the first of said payments being due October 8, 1980 and a like installment due on the same day of each month thereafter until paid in full; said payments including interest at the rate of 18% percent per annum.
