Together with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging or in any wise incident or appertaining,

- 1. The holder of this mortgage, in any action to foreclose the same, shall be entitled, without regard to the value of the mortgaged premises, or the adequacy of any security for the mortgaged debt, to the appointment of a receiver of the reats and profits of the mortgaged premises, and such reats and profits are hereby, in the event of any default in the payment of said Agreement according to its terms, assigned to the holder of this mortgage.
- The covenants herein contained shall bind and the benefits shall inure to the respective beirs, executors, administrators, successors and assigns of the parties hereto.
