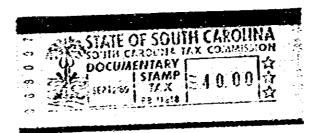

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, bying and being in the State of South Carolina, County of Greenville, being shown as Lots 217, 218, 219 and 220 on plat of Cuttino Heirs, recorded in Plat Book J at page 121 and also as Lots 1 and 2 on plat of Property of Cora B. Pletcher, recorded in Plat Book 5-D at page 35, and having the following metes and bounds, to wit:
