## MORTGAGE

NOW, KNOW ALL MEN, that the martgagor(s) in consideration of the sold debt, and for the better securing the payment thereof, according to the conditions of the sold Note; which with all its provisions is hereby made a part hereof; and also in consideration of Three Dollars to the sold mortgagor in band well and truly paid, by the sold martgager, at and before the sealing and delivery of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the
said martgager, its (his) heirs, successors and assigns forever, the following described real estate:

ALL that piece, parcel or lot of land, with the improvements thereon, situate, lying and being near the City of Greenville, Greenville County, South Carolina, and being more particularly described as Lot No. 26, Section A, as shown on a plat entitled "A Subdivision for Woodside Mills, Greenville, S.C.", made by Pickell & Pickell, Engineers, Greenville, S.C. January 14, 1950; and recorded in the RMC Office for Greenville County in Plat Book W, at Page 111-117, inclusive. According to said plat the within described lot is also known as No. 45 East Fifth Street (Avenue) and fronts thereon 89 feet. According to a plat made by Carolina Surveying Co., entitled "Property of Mary R. Lee" dated July 16, 1976 the above described lot has the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeast side of East Fifth Street, joint front corner of Lots 25 and 26 and running thence with Lot 25 N. 15-49 E. 97.2 feet to an iron pin; thence turning and running S. 73-34 E. 81.5 feet to an iron pin, on Vance Street and running thence with Vance Street S. 11-19 W. 96.6 feet to an iron pin on East Fifth Street, and running thence with said East Fifth Street N. 74-11 W. 89.0 feet to an iron pin, the beginning corner.

This property is conveyed subject to any easements, restrictions, or rights-of-way, if any, affecting the above-described property.

As recorded in the records of the RMC Office for Greenville County, South Carolina, the title is now vested in Mary R, Lee by deed of Henry C, Suddeth and Dunice B, Suddeth as recorded in Deed Book 1039 at Page 968 on July 21, 1976.

IT IS HEREBY UNDERSTOOD THAT THIS MORTGAGE CONSTITUTES A VALID SECOND LIEN ON THE TOGETHER with all and singular the rights, scenbers, bereditatents and appartengances to the said premises belonging, or in anywhat incident or appartatalog. ABOVE DESCRIBED PROPERTY.

TO HAVE AND TO HOLD, all and singular the said Premises unto the said mortgages, its (his) successors, helps and assigns forever.

AND I (we) do hereby bind my (our) self and my (our) heirs, executors and administrators, to procure or execute any further necessary assurances of title to the soid premises, the title to which is unencumbered, and also to warrant and forever defend all and singular the said Premises into the said mortgages its (his) heirs, successors and assigns, from and against all persons lawfully claiming, or to claim the same or any part thereof.

AND IT IS AGREED, by and between the parties bereto, that the said mortgagor(s) his (their) heirs, executors, or animistrators, shall keep the buildings on said premists, issued against loss or damage by fire, for the benefit of the said mortgages, for an amount not less than the unput blance on the said Note in such company as shall be approved by the said mortgages, and in default thereof, the said mortgages, its (his) heirs, successors or assigns, may effect such insurance and reimburse thesestives under this mortgage for the expense thereof, with interest thereon, from the date of its payment. And it is further agreed that the said mortgages its (his) heirs, successors or assigns shall be entitled to receive from the insurance moneys to be paid, a successor to the amount of the debt secured by this mortgage.

AND IT IS AGREED, by and between the said parties, that if the said markaparts), his (their) heirs, executors, administrators or assigns, shall full to pay all laxes and assessments upon the said premises when the same shall first become payable, then the said markapage, its (his) heirs, successors or assigns, may cause the same to be paid, sogether with all penalities and costs incurred thereon, and relationse themselves under this markapage for the same so paid, with interest thereon, from the dates of such payments.

AND IT is AGREED, by and between the said parties, that upon any default being made in the payment of the said Note, when the same shall become payable, or in any other of the provisions of this mortgage, that then the entire amount of the debt secured, or intended to be secured hereby, shall forthwith become due, of the option of the said marriagee, its (bis) heles, successors or assigns, although the period for the payment of the said debt may not then have expired.

AND IT IS FURTHER AGREED, by and between the said parties, that should legal proceedings be instituted for the foreclosure of this mortgage, or for any purpose involving this mortgage, or should the debt bereby secured be placed in the hands of an attameny at law for collection, by suit or otherwise, that all costs and expenses incurred by the mortgages, its (his) helies, successors or assigns, including a reasonable counsel fee (of not less than ten per cent of the amount involved) shall thereupon become due and purpose as a part of the debt secured hereby, and may be recovered and collected hereunder.

PROVIDED, ALWAYS, and it is the true intent and meaning of the parties to these Presents, that when the said martgager, his (their) being executors or administrators shall pay, or cause to be paid into the said martgager, its (his) heirs, successors or assigns, the said debt, with the interest thereon, if any shall be due, and also all sums of many paid by the said corrigager, his (their) heirs, successors, or assigns according to the conditions and agreements of the said note, and of this martgage and shall perform all the obligations according to the intent and meaning of the said note and martgager, then this Deed of Bargain and Sale shall cause, determine and be void, otherwise if shall reason in full force and virtue.

AND IT IS LASTLY AGREED, by and between the entit parties, that the entit contagger may hold and enjoy the entit premises until default of payment shall be made.
