MORTGAGE

THIS MORTGAGE is made this 7th day of OCTOBER, 1980, between the Mortgagor, JAMES M. WALLACE AND NANCY J. WALLACE, (herein "Borrower"), and the Mortgagee, First Federal Savings and Loan Association, a corporation organized and existing under the laws of the United States of America, whose address is 301 College Street, Greenville, South Carolina (herein "Lender").

WHEREAS Borrower is indebted to Lender in the principal sum of FORTY-NINE THOUSAND AND NO/100 Dollars, which indebtedness is evidenced by Borrower's note dated OCTOBER 7, 1980, (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on NOVEMBER 1, 2010.....;

ALL that certain piece, parcel or lot of land situate, lying and being in the City of Simpsonville, County of Greenville, State of South Carolina, and being known and designated as Lot No. 200 on a plat of Brentwood, Section IV, recorded in the RMC Office for Greenville County, South Carolina in Plat Book 5-D at Page 43, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point on Doral Way at the joint front corner of Lots Nos. 200 and 201 and running thence with said line S. 17-52 E. 162.85 feet to a point; thence running S. 72-12 W. 120.0 feet to a point; thence running N. 17-53 W. 162.6 feet to a point; thence running with Doral Way N. 72-02 E. 120.0 feet to the point of beginning.
