

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, All that certain lot of land in Greenville Township, Greenville County, State of South Carolina, in the City of Greenville, on Jones Avenue, known and designated as Lot N.14 as shown on plat of property of W. C. McDaniel prepared by R. E. Dalton, Engineer, January 1924, recorded in the R.M.C. Office for Greenville County in Plat Book "F" at Page 186, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the East Side of Jones Avenue, corner of Lot 13, thence S. 89-0 E. 198.8 feet to iron pin at corner of Lots 13, 26, and 25; thence with rear line of lot 25, S. 5-08W. 70.18 feet to iron pin, corner of Lots 25,24 and 15; thence with line of Lot 15, N. 89-0W. 193.7 feet to and iron pin on East Side of Jones Avenue; thence with the East side of Jones Avenue, N. 1-0E. 70 feet to the beginning corner.
