ALL that piece, parcel or lot of land, in the City of Greenville, County of Greenville, State of South Carolina situate on the south side of Watts Avenue (formerly Lucile Avenue) being designated as Lots 8 and 9 of Block J in Plat Book E, page 41 recorded in the RMC Office for Greenville County and having the following metes and bounds to-wit:
