

ALL that piece, parcel or lot of land, situate, lying and being in the County of Greenville, State of South Carolina, on the Eastern side of Nash Street (formerly Hunt Avenue), being known and designated as Lots Nos. 25 and 26 as shown on map of EAST PARK, which is a part of BOYCE ADDITION, as evidenced by record in the RMC Office for Greenville County, South Carolina, in Plat Book A at Page 383, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Eastern side of Nash Street, Northwestern corner of Lot 26, and running thence with Nash Street, S. 23-30 W., 96 feet to an iron pin: running thence with Lot 24 in a Southeastern direction, 156 feet to a point on a 10foot alley at the joint rear corner of Lots 24 and 25; thence running with said 10foot alley, N. 43-15 E., 71 feet to joint rear corner of Lots 25 and 26; thence continuing with said 10-foot alley, N. 12-15 E., 123 feet to a point at the joint rear corner of Lots 7 and 26; thence running S. 72-45 W., 200 feet along the rear of Lots 4, 5, 6 and 7 to beginning corner.
