TO ALL WHOM THESE PRESENTS MAY CONCERN:

THIS MORTGAGE, made this 14th day of November, 19 80 by Beatty D. Barrett
and Marjorie Barrett hereinafter called the Mortgagor, in the State aforesaid, Witnesseth:

NOW, KNOW ALL MEN BY THESE PRESENTS that the said Mortgagor in consideration of the said debts and sums of money aforesaid and for the better securing of the payment thereof, and also to secure the payment of any other sums advanced to said Mortgagor under the terms and provisions of this Mortgage as hereinafter set forth, to the said Mortgagee according to the condition of said note, and also in consideration of the further sum of Three Dollars to the said Mortgagor in hand well and truly paid by the said Mortgagee, at and before the sealing and delivery of these presents, the receipt of which is hereby acknowledged, have granted, bargained, sold and released and by these presents do grant, bargain, sell and release unto the said Mortgagee, its successors and assigns, the following described property

ALL that lot of land situate on the northeastern side of Plantation Drive being shown as Lot No. 23 on a plat of Holly Tree Plantation, Phase III, Section I, Sheet 2, dated September 1, 1978, prepared by Piedmont Engineers, Architects & Planners, recorded in Plat Book 6-H, at Page 75, in the RMC Office for Greenville County, S. C. and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeastern side of Plantation Drive at the joint front corner of Lot 22 and Lot 23 and running thence with Lot 22, N. 45-05 178.32 feet to an iron pin at the joint rear corner of Lot 23 and Lot 22; thence S. 45-56 E. 110 feet to an iron pin at the joint rear corner of Lot 23 and Lot 24; thence with Lot 24, S. 47-00 W. 170 feet to an iron pin on Plantation Drive; thence with said Drive, N. 45-24 W. 32 feet to an iron pin; thence still with said Drive, N. 52-52 W. 73 feet to the point of beginning.
