All that certain piece, parcel, or lot of land, situate, lying and being in Gantt Township, Greenville County, South Carolina, being shown and designated as Lot 55 on Plat of PECAN TERRACE, recorded in the RMC office for Greenville County in Plat Book GG, at Page 9, and having according to a more recent survey by Freeland & Associates, dated April 27, 1978, the following metes and bounds:

BEGINNING at an iron pin on the northeastern side of Rocky Knoll Drive, joint front corner of Lots 54 and 55, and running thence with the common line of said Lots, N 64-34 E, 178.0 feet to an iron pin; thence with the rear line of Lot 55, S 28-24 E, 70.05 feet to an iron pin, joint rear corner of Lots 55 and 56; thence with the common line of said Lots, S 64-34 W, 181.6 feet to an iron pin on the northeastern side of Rocky Knoll Drive; thence with said Drive, N 25-26 W, 70.0 feet to an iron pin, the point of beginning.
