Nothing contained in this paragraph 7 shall require Lender to incur any expense or take any action bereunder.

8. Inspection. Lender may make or cause to be made reasonable entries upon and inspections of the Property, provided that Lender shall give Borrower notice prior to any such inspect on specifying reasonable cause therefor related to Lender's interest in the Property.
