Any amounts dishirsed by Lender pursuant to this paragraph T, with interest thereon, shall become additional indebtedness of Borrower secured by this Mortgage. Unless Borrower and Lender raree to other terms of payment, such amounts shall be payable upon notice from Lender to Borrower recliesting promein thereof, and shall be at literest from the date of dishirsement at the rate payable from time to time on constanding principal under the Note unless payment of interest at such rate would be contrary to applicable law, in which event such amounts shall bear interest at the highest rate permissible under applicable law. Nothing contained in this paragraph 7 shall require Lender to ment any expense or take any action hereunder.
