To All Whom These Presents May Concern:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Town of Simpsonville, on the west side of Willowtree Drive and being shown and designated as Lot 388 on plat of Section 4 of Westwood Subdivision as recorded in the RMC Office for Greenville County in Plat Book 4R, Page 30 and having according to said plat, such metes and bounds, as appear thereon.

This is the identical property as conveyed to the grantor by deed of Foothills Delta P, Inc. as recorded in the RMC Office for Greenville County in Deed Book 1037, Page 802 recorded 6/11/76.
