At no time shall the principal amount of the indebtedness secured by this Mortgage, rict including sums advanced in accordance herewith to protect the security of this Mortgage, exceed the original amount of the Note phis USS None.

22. Release. Upon payment of all sums secured by this Mortgage, this Mortgage shall become null and void, and Lender shall release this Mortgage without charge to Borrower. Borrower shall pay all costs of recordation, if any,

23. Waiser of Homestead. Borrower hereby waives all right of homestead exemption in the Property.
