That the Mortgagor, in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the said Mortgagee, its successors and assigns, the following described real estate, to wit:

ALL that piece, parcel or lot of land lying and being in the City of Greenville, County of Greenville, State of South Carolina, and being known as Lot No. 39 on a plat of East Over Subdivision, made by R. E. Dalton, Engineer, dated July 1920, and being recorded in the RMC Office in Plat Book F page 42 and having the following metes and bounds to wit:
