"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville on Goodrich Street, in Greenville Township, in a subdivision known as Westview, near Judson Mills, and being a part of Lot No. 4 of the property of J.
