WITNESSETH:

THAT WHEREAS, Dorothy P. Boggs  
is indebted to Mortgagee in the maximum principal sum of Twenty Nine Thousand and No/100-----  
Dollars (\$ 29,000.00 ), which indebtedness is  
evidenced by the Note of G. Thomas Boggs and Dorothy P. Boggs of even  
date herewith, said principal together with interest thereon being payable as provided for in said Note, the final maturity of  
which is 184 months after the date hereof, the terms of said Note and any agreement modifying it  
are incorporated herein by reference.

NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS that the said Mortgagor, for and in consideration of the aforesaid  
indebtedness and in order to secure the payment thereof together with any renewals or extensions or modifications thereof upon the  
same or different terms or at the same or different rate of interest and also to secure in accordance with Section 29-3-50, as amended,  
Code of Laws of South Carolina (1976): (i) all future advances and readvances that may subsequently be made to Mortgagor by  
Mortgagee evidenced by the aforesaid Note, or by other promissory notes, and all renewals and extensions thereof; and (ii) all other  
indebtedness of Mortgagor to Mortgagee, now or hereafter existing, whether direct or indirect, the maximum amount of all  
indebtedness outstanding at any one time secured hereby not to exceed \$ 29,000.00 plus interest thereon, all  
charges and expenses of collection incurred by Mortgagee including court costs and reasonable attorney's fees, has granted,  
bargained, sold, released and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns,  
the following described property:

All that certain piece, parcel or lot of land, situate, lying and being  
in the State of South Carolina, County of Greenville, on the South  
side of Hudson Road, and being shown as as 1.19 acre tract of land  
on plat entitled Property of Dorothy P. Boggs, made by Freeland and  
Associates, dated March, 1978, and recorded in the RMC Office for  
Greenville County, S.C. in Plat Book 6-0 at Page 65, recorded on  
April 26, 1978, and having, according to said plat, the following metes  
and bounds, to-wit:

BEGINNING at a point in the center of Hudson Road at the corner of  
Property herein described and property now or formerly of James Barton  
and runs thence along the line of property now or formerly of James  
Barton S. 13-00 E. 292.5 feet to an iron pin; thence S. 75-25 W. 190.8  
feet to an iron pin; thence N. 15-50 W. 289.5 feet to a point in the  
center of Hudson Road; thence along the center of said Road, N. 73-50  
E. 204 feet to the point of beginning.
