

To Secure to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of . ALL that certain piece, parcel or lot of land, situate, lying and being on the east side of Broadmoor Drive, Greenville County, South Carolina, being shown and designated as Lot 46 on a plat of Section 2 of LAKE FOREST HEIGHTS, recorded in the RMC Office for Greenville County in Plat Book KK at Page 105, and having, according to a more recent plat made by Freeland & Associates, dated February 2, 1981, and recorded in Greenville County Plat Book & at Page 51, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Broadmoor Drive, at the joint front corner of Lots 45 and 46, and running thence with the line of Lot 45, N. 83-15 E. 155.1 feet to pin in line of Lot 50; thence with the lines of Lots 49 and 50, N. 4-55 W. 149.8 feet to pin, rear corner of Lot 47; thence with the line of Lot 47, S. 74-42 W. 164.4 feet to an iron pin on Broadmoor Drive; thence with the eastern side of Broadmoor Drive, S. 11-30 E. 60.5 feet to an iron pin; thence continuing with Broadmoor Drive, S. 4-43 E. 65 feet to an iron pin, the point of beginning.
