THIS MORTGAGE is made this 6th day of February 19 81 between the Mortgagor, BOB MAXWELL BUILDERS, INC. (herein "Borrower"), and the Mortgagee, FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION a corporation organized and existing under the laws of the United States whose address is 101 EAST WASHINGTON STREET, GREENVILLE, SOUTH CAROLINA (herein "Lender").

All that piece, parcel or lot of land situate, lying and being on the northern side of Wiltshire Court, in the County of Greenville, State of South Carolina, being shown and designated as Lot No. 41 on a plat of Windsor Oaks, Sec. II, recorded in the RMC Office for Greenville County, South Carolina, in Plat Book 7-C, at page 13, and having, according to said plat, and a more recent survey entitled "Property of Bob Maxwell Builders", prepared by Freeland & Associates, dated December 19, 1980, the following metes and bounds:

BEGINNING at an iron pin on the northern side of Wiltshire Court at the joint front corner of Lots 41 and 42, and running thence with the line of Lot No. 42, N. 20-22-00 W. 128.34 feet to an iron pin in the line of Lot No. 23; thence with the line of Lots Nos. 23 and 22, N. 69-38-00 E. 124 feet to an iron pin in the line of Lot No. 40; thence with the line of Lot No. 40, S. 20-22-00 E. 119.97 feet to an iron pin on the northern side of Wiltshire Court; thence with the northern side of Wiltshire Court, S. 69-38-00 W. 45.03 feet to an iron pin; thence continuing with the northern side of Wiltshire Court, S. 63-35-00 W. 79.41 feet to the point of beginning.

This is the identical property conveyed to the Mortgagor herein by deed of Windsor Group, Inc., dated January 8, 1980, and recorded in the RMC Office for Greenville County, South Carolina, in Deed Book 1118, at page 721, on January 10, 1980.

In addition to and together with the monthly payments of principal and interest under the terms of the Note secured hereby, the Mortgagor promises to pay to the Mortgagee a monthly premium necessary to carry private mortgage guaranty insurance until the principal balance reaches 80% of the original sales price or appraisal, whichever is less. The estimated monthly premium for the first nine years will be .02% of the original amount of the loan. The estimated monthly premium for each year thereafter will be .01% of the original principal balance of this loan. The Mortgagee may advance this premium and collect it as part of the debt secured by the mortgage if the Mortgagor fails to pay it.

Borrower covenants that Borrower is lawfully seised of the estate hereby conveyed and has the right to mottgage. Ogrant and convey the Property, that the Property is unencumbered, and that Borrower will warrant and defend generally the title to the Property against all claims and demands, subject to any declarations, easements or restrictions listed in a Hischedule of exceptions to coverage in any title insurance policy insuring Lender's interest in the Property.
