And it is further agreed that in the case of foreclosure of this mortgage, by suit or otherwise, the Mortgagee shall recover of the Mortgagor the expense of advertising, selling and conveying, including reasonable attorney's fees and other reasonable costs of foreclosure, which shall be secured by this mortgage, and shall be included in judgment of foreclosure. Further, Mortgagor agrees to pay Mortgagee reasonable attorney's fees in the event Mortgagee becomes involved in any suit, proceeding or claim involving this mortgage or title to the property described herein

And it is covenanted and agreed that no failure of the Mortgagec or its successors or assigns to exercise any option to declare the maturity of any debt secured by this mortage, shall be taken or deemed as a waiver of its right to exercise such option, or to declare such torteiture, either as to any past or present default, and it is further agreed that no terms or conditions contained in this mortgage can be waived, altered or changed except as evidenced in writing and signed by all parties hereto.
