(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto Associates Financial Services Co Inc

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

Twenty Thousand One Hundred Sixty and no/100 DOLLARS (\$ 20,160.00),
with interest thereon from date at the rate of 18 per centum per annum, said principal and interest to be repaid: in 96 equal monthly installments of \$210.00 each, the first of said payments being due March 20, 1981, and a like installment due on the same day of each month thereafter until paid in full; said payments including interest at the rate of 18% per annum.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Northern side of DeOyley Avenue, being shown and designated as Lot Number 211 of Augusta Road Ranches on plat recorded in Plat Book M at Page 47 of the RMC Office for Greenville County.
