All that piece, parcel or lot of land in the City of Greenville, County of Greenville, State of South Carolina, on the Northern side of Prancer Avenue, being known and designated as Lot No. 276, Pleasant Valley, according to a plat of said subdivision prepared by Dalton & Neves, April, 1946, including additions to said plat through November, 1948 as recorded in the RMC Office of Greenville County in Plat Book "P" at Page 92. Reference being craved to said plat for a more particular metes and bounds description.

This is the same property conveyed to the mortgagors herein by deed of W. C. McMillan dated March 13, 1981 and recorded in the RMC Office of Greenville County in Deed Book 1144 at Page 414.

The Mortgagor further covenants and agrees as follows:
