"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville and being on the Northwestern side of Sandy Springs Road and being shown as a 32.83 acre tract of property according to a plat made by C. L. Riddle entitled "Property of Annie Alverson Reid" dated December 19, 1972, reference being has to said plat for a more complete notes and bounds description. This property is also shown on the Block Books for Greenville County as Lot 11.1, Block 1, Sheet 595.2.
