Now, therefore, it is covenanted and agreed as follows:

- -(1) The total tap fee currently due from Owner(s) to the Subdistrict for the Property is \$\_400.00
- (2) Owner(s) agree to pay said tap fee in installments as follows: 100.00 paid down at this time; (b) the balance of \$ 300.00 to be paid in equal annual installments of \$ 100.00 each, plus interest on the unpaid balance at the rate of eight (8%) percent per annum, commencing one year from this date. All accrued interest shall be due and payable annually, together with the annual principal payment. Each payment shall be made when due at the business office of the Subdistrict in Greenville, South Carolina.
- (3) If any installment is not paid when due, then the entire unpaid balance of the tap fee shall immediately become due and payable, together with interest at the rate of eight (8%) percent per annum which shall continue to accrue until full payment is made.
