SECOND MORTGAGE

THIS MORTGAGE, made this 8th day of April 1981 by and between M. Scott Hughes & Dawn McNeill Mitchell

ALL that piece, parcel or lot of land in the County of Greenville, State of South Carolina, on the northern side of Stanley Drive, near the City of Greenville, being shown as Unit 80 on a plat of Harbor Towne, recorded in the R. M. C. Office for Greenville County in Plat Book 5P, at Pages 13 and 14, and being more particularly described as follows:

BEGINNING at a point at the joint corner of Units 80 and 81 and thence running S. 50-50 E. 83 feet; thence turning and running S. 39-10 W. 20.7 feet; thence turning and running N. 50-50 W. 83 feet; thence turning and running N. 39-10 E. 20.7 feet to the point of beginning.
