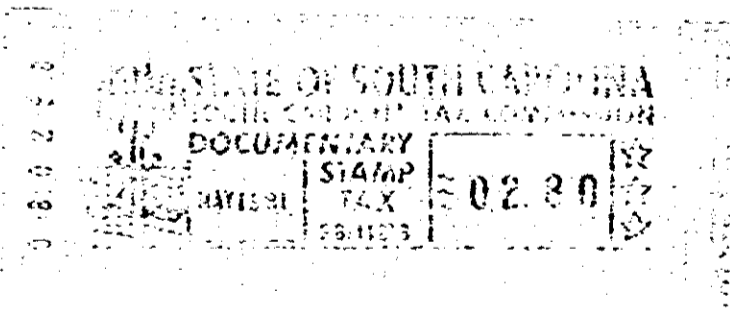

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE, being shown and designated as 4.02 acres, more or less, on plat entitled "Survey for David A. Greer and Pam D. Mitchell", prepared by Carolina Surveying Company, dated May 11, 1981, and being more particularly described in accordance with said plat, to-wit:
