To secure payment of a note which I signed today promising to pay you the above Total of Payments and to secure all my other and future obligations to you, the Maximum Outstanding of any given time not to exceed the amount stated above, each of the undersigned grants, bargains, sells and releases to you the real estate described below and all present and future improvements on the real estate, which is located in South Carolina, County of Greenville

ALL that piece parcel or lot of land situate in the State of South Carolina, County of Greenville lying and being on the northern side of East Yenilworth Dr., being known and designated as Lot No. 48 as shown on Plat of Kingsgate, made by Piedmont Eng. and Architects and recorded in the PWC Office for Greenville County, in plat book 477 at pages 44 and 45 and having according to said plat, the following metes and bounds, to wit: BEGINNING at an iron pin on the northern side of East Yenilworth Dr., at the joint front corner of Lots 47 and 48 and running thence along the common line of said lots N. 16-44 W. 265.9 Ft to an iron pin; thence running S. 57-42 E. 124.7 ft. to an iron pin at the joint rear corner of lots 48 and 49; thence with the common line of said lots S. 16-50 E. 223.7 Ft. to an iron pin on the northern side of East Yenilworth Dr., thence with the line of said dr.
