TO WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, I, MAYS L. CAPPS

(hereinafter referred to as Mortgagor) is well and truly indebted unto

ADITH R. PENLAND AND MARY LEE OGLSBY

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

FOUR THOUSAND DOLLARS AND NO/100----- Dollars (\$ 4,000.00) due and payable

ACCORDING TO THE TERMS OF THE NOTE OF EVEN DATE HEREWITH FOR WHICH THIS MORTGAGE STANDS AS SECURITY.

with interest thereon from date at the rate of 10% per centum per annum, to be paid: monthly.

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

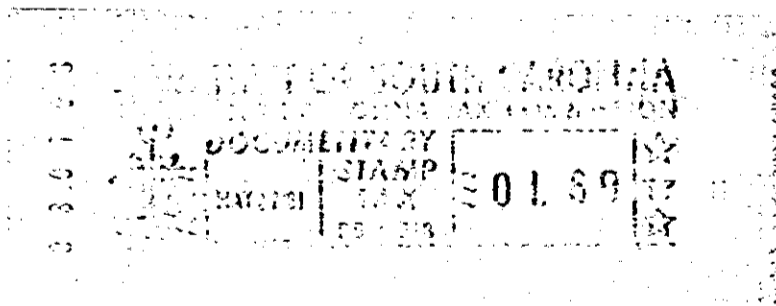
"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Marietta, State of South Carolina, Bates Township, which includes three (3) tracts of land, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the joint corners of this property and that of Martin and running N. 54-45 E. 60 feet to an iron pin; thence S. 52-24 W. 40 feet; thence S. 16-26 W. 61 feet to the beginning corner.

ALSO, that property beginning at an iron pin on the joint corners of lands of Moody and Baker and running S. 40-30 E. 47.1 feet to an iron pin on the North side of a street; thence with said street S. 19 W. 60 feet to an iron pin; thence N. 45-30 W. 83 feet to an iron pin; thence S. 54-30 E. 60 feet to the beginning corner.

ALSO, a traingular strip containing 0.08 acres, beginning at an iron pin at the corner of property conveyed by S. C. Moody to James Harry Batson and Julia R. Batson, and running thence S. 54-30 E. 120 feet to an iron pin; thence S. 40-30 E. 60 feet to an iron pin; thence N. 27-00 E. 120 feet to the point of beginning.

THIS is the same property conveyed to the Mortgagor herein by deed of Adith R. Penland and Mary Lee Oglsby dated May 25, 1981, and recorded simultaneously herewith.
