To secure payment of a note which I signed today promising to pay you the above Total of Payments and to secure all my other and future obligations to you, the Maximum Outstanding of any given time not to exceed the amount stated above, each of the undersigned grants, bargains, sells and releases to you the real estate described below and all present and future improvements on the real estate, which is located in South Carolina, County of Greenville

All that certain piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, being known and designated as Lot 61, Section One of Peace Haven as shown on plat recorded in the R. M. C. Office for Greenville County in Plat Book VV at Page 83 and having the following metes and bounds, to-wit:

BEGINNING at an iron pin at the northwestern corner of the intersection of Pine Drive and Elm Street and running thence with Elm Street, N. 21-24 W. 100 feet to an iron pin at the corner of Lot 62; thence with the line of Lot 62, S. 64-57 W. 200 feet to an iron pin at the joint rear corner of Lots 61 and 62; thence with the line of Lot 66, S. 21-24 E. 100 feet to the beginning corner.

If I am in default for failure to make a required payment for 10 days or more, you may send me a notice giving me 20 days to eliminate the default. If I do not eliminate the default in the manner stated in the notice, or if I eliminate the default after you send the notice but default on a future payment by failing to pay on schedule, or if my ability to repay my loan or the condition, value or protection of your rights in the collateral securing my loan is significantly impaired, then the full amount I owe, less any charges which you have not yet earned, will become due, if you desire, without your advising me.

I will pay all expenses you incur in enforcing any security interest, including reasonable attorney's fees as permitted by law.

Each of the undersigned agrees that no extension of time or other variation of any obligation secured by this mortgage will affect any other obligations under this mortgage.

Each of the undersigned waives marital rights, homestead exemption and all other exemptions under South Carolina law.

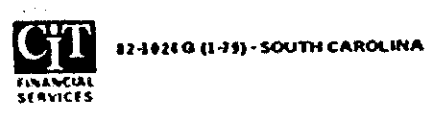
