(hereinafter also styled the mortgogor) in and by my (our) certain Note bearing even date herewith, stand firmly held Poinsett Discount Co., Inc., Greenville, S. C. , (hereinaiter also styled the mortgag s_6,901.80 equal installments of \$ 115.03

19 81 lst July add Note and conditions thereof, reference thereunto had will more fully appear.

HOW, KNOW ALL MEN, that the marigagor(s) in consideration of the said debt, and for the better securing the payment thereof, according to the conditions of the enid Note; which with all its provisions is hereby made a part hereof; and also in consideration of Three Dollars to the enid mortgager in hand well and truly paid, by the said mortgager, at and before the sealing and delivery of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said mortgages, its (his) heirs, successors and assigns forever, the following described real estate:

ALL THAT CERTAIN PIECE, PARCEL OR LOTS OF LAND, SITUATE, LYING AND BEING ON THE western side of Texas Avenue, in the County of Greenville, State of South Carolina, being shown and designated as Lot 3 and portion of Lot 2 on Plat of H.K. Twwnes Property, recorded in the RMC office for Greenville County in Plat Book K, at Pages 50 and 51, and having, according to a more recent survey by Preeland& Associates, dated February 19, 1976, the following metes and bounds:

BEGINNING at an iron pin on the western side of Texas Avenue, joint front corner of Lots 3 and 4, and running thence along the common line of said Lots, S. 67-50 W. 199.6 feet to an iron pin; thence N. 22-10 W. 64.0 feet to an iron pin, joint rear corner of Lots 2 and 3; thence N. 67-50 E. 128.6 feet to an iron pin; thence N. 22-10 W. 6.0 feet to an iron pin; thence N. 67-50 E. 71.0 feet to an iron pin on the western side of Texas Avenue; thence with said Texas Avenue S. 22-10 E. 70.0 feet to the point of beginning.

This conveyance is subject to all restrictions, set back lines, roadways, zoning ordinances, easements, and rights of way, if any, affecting the above property.

As recorded in the records of the RMC Office for Greenville County, South Carolina the title is now vested in Ramon A. Pineda and Rosa A. Pineda by deed of William F, Brown and Nancy C. Brown as recorded in Deed Book 1031 at Page 940 on February 23, 1976. IT IS HEREBY UNDERSTOOD THAT THIS MORTGAGE CONSTITUTES A VALID SECOND LIEN ON THE ABOVE THER with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or apportaining. DESCRIBED PROPERTY.

TO HAVE AND TO HOLD, all and singular the said Premises unto the said mortgages, its (his) successure, heirs and assigns forever.

AND I (we) do hereby bind my (our) self and my (our) heirs, executors and administrators, to procure or execute any further necessary as surances of title to the said premises, the title to which is unencumbered, and also to warrant and forever defend all and singular the said Premises unto the said mortgagee its (his) heirs, successors and assigns, from and against all persons lawfully claiming, or to claim the some or any part thereof.

AND IT IS AGREED, by and between the parties hereto, that the said mortgagor(s) his (their) heirs, executors, or administrators, shall keep the buildings on said premises, insured against loss or damage by fire, for the benefit of the said mortgagee, for an amount not less than the unpaid balance on the said Note in such company as shall be approved by the said mortgages, and in default thereof, the said mortgages, its (his) heirs, successors or assigns, may effect such insurance and relimburse themselves under this mortgage for the expense thereof, with interest thereon, from the date of its payment. And it is further agreed that the said mortgages its (his) heirs, successors or assigns shall be entitled to receive from the insurance moneys to be pold, a sum equal to the amount of the debt secured by this mortgage.

AND IT IS AGREED, by and between the said parties, that if the said mortgagor(s), his (their) heirs, executors, administrators or assigns, shall fail to pay all taxes and assessments upon the said premises when the same shall first become payable, then the said mortgages, its (his) heirs, successors or assigns, may cause the same to be paid, together with all penalties and costs incurred thereon, and reimburse themselves under this mortgage for the sums so paid, with interest thereon, from the dates of such payments.

AND IT IS AGREED, by and between the said parties, that upon any default being made in the payment of the said Note, when the same shall become payable, or in any other of the provisions of this mortgage, that then the entire amount of the debt secured, or intended to be hereby, shall forthwith become due, at the option of the said mortgages, its (his) heirs, successors or assigns, although the period for the payment of the said debt may not then have expired.

AND IT IS FURTHER AGREED, by and between the said parties, that should legal proceedings be instituted for the foreclosure of this mortgage, or for any purpose involving this mortgage, or should the debt hereby secured be placed in the hands of an attorney at law for colreasonable counsel fee (of not less than ten per cent of the amount involved) shall thereupon become due and payable as a part of the debt secured hereby, and may be recovered and collected hereunder.

PROVIDED, ALWAYS, and it is the true intent and meaning of the parties to these Presents, that when the said mortgagor, his (their) heirs, executors or administrators shall pay, or cause to be paid unto the said mortgages, its (his) heirs, successors or assigns, the said debt, with the interest thereon, if any shall be due, and also all sums of money paid by the said mortgages, his (their) heirs, successors, or assigns, according to the conditions and agreements of the said note, and of this mortgage and shall perform all the obligations according to the true intent and meaning of the said note and mortgage, then this Deed of Bargain and Sale shall cease, determine and be void, otherwise it shall remain in full force and virtue.

AND IT IS LASTLY AGREED, by and between the eaid parties, that the said mortgogor may hold and enjoy the said premises until default of payment shall be made.
