with interest thereon from date at the rate of / per centum per annum, to be paid per note

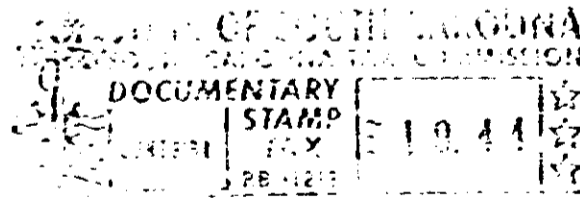

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the Town of Simpsonville, being known and designated as Lot No. 15 of a subdivision known as PINETREE, said plat being recorded in the RMC Office for Greenville County in Plat Book 5D at Page 63, and having the following metes and bounds, to-wit:

BEGINNING at a point on Needles Drive, joint front corner with Lots No. 14 and 15 and running thence N. 75-00 E., 10 feet; thence S. 68-13 E., 40 feet; thence N. 67-10 E., 35 feet, joint front corner with Lots No. 15 and 16; thence S. 39-48 E., 150.65 feet to the joint rear corner with Lots No. 15 and 16; thence S. 75-50 W., 140 feet to the joint rear corner of Lots 14 and 15; thence N. 15-00 W., 154 feet to a point, the point of beginning.
