To secure payment of a note which I signed today promising to pay you the above Total of Payments and to secure all my other and future obligations to you, the Maximum Outstanding at any given time not to exceed the amount stated above, each of the undersigned grants, bargains, sells and releases to you the real estate described below and all present and future improvements on the real estate, which is located in South Carolina, County of **Greenville**

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Butler Township, near and East of the City of Greenville, and being known and designated as Lot or Tract Number 25 of subdivision known as Boiling Spring Estates, a plat of which is of record in the RMC Office for Greenville County in Plat Boox YY at Pages 14-15, and having the following metes and bounds, to-wit:

Beginning at a point on the Eastern side of Browning Drive at the joint front corner of Lots 25 and 26, and running thence with the Eastern side of Browning Drive S 17-17 E 180 feet to a point; thence following the curvature of the Northeastern Intersection of Browning Drive with Phillips Road (the chord of which is S 58-47 E) 30 feet to a point; thence with the Northern side of Phillips Road N 79-43 E approximately 392 feet to a point in a branch, said point being the rear corner of Lot 25; thence with said branch as a line approximately N 34-09 W approximately 138.6 feet to a point; thence continuing with said branch as a line approximately N 37-47 W approximately
